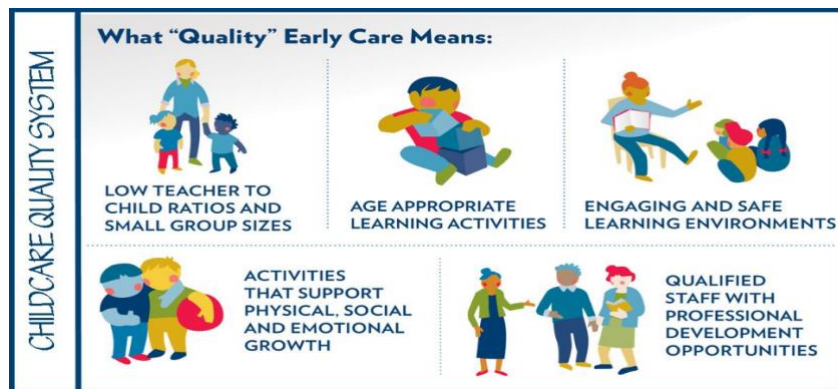

First 5 Mono Childcare Quality Funding Streams: First 5 Mono offers advising, professional development, Community of Practice groups, and stipends upon completion of program requirements to Childcare and Education Centers, Preschools, Family Child Care Homes (FCCH), and Family Friend and Neighbor (FFN) care providers to support quality childcare and education in our communities as part of the Quality Counts California State initiative. QCC Mono/Alpine Workforce Pathways Stipend Program (WPSP): The Workforce Pathways Grant was designed to focus on staff retention. The goal is to build upon and reinforce the early learning and care workforce through a workforce advising team. The workforce advising team focuses on requirements to establish a professional growth plan, meet with the advisor 2-3 times that year and complete one professional growth hours in one of the following ways; professional development, degree attainment and attainment or advancement on the CA Child Development Permit Matrix. If a provider successfully completes this program, they will be eligible for a stipend based on their level of completion.
